

Parking App Available

Is downtown parking a struggle? Does finding pocket change to put in meters wear you out? Did you know there is an App you can use that links directly to your bank account so all you have to do in punch in a number when you find a great spot to park downtown in a Republic lot?

Take a few minutes to check out the ParkMobile App—you can find it on your iStore or GooglePlay for Android users. This app is free and uses the GREEN lot number for Republic Parking lots to identify where you are parking! You enter your license plate and car information (and you can add multiple cars) and your bank information to park all over downtown.

The app also allows you to FIND your car if you forget where you parked! You will also receive a notification as you get close to your allotted time and you can reload most meters from your phone!

With our new meeting location, finding a meter on the street might be the simplest way to park.
